A. On Plaintiffs' Complaint

1. Judgment in favor of Plaintiff Nutrex, Inc. and  
against Defendant Biotec Foods-Hawaii, Ltd. in the  
amount of \$68,583.03, plus interest of \$20,208.31,  
plus attorney fees of \$12,413.26, plus statutory

attorney commissions of \$2,851.53, plus costs of \$2,199.94, for a total of \$106,526.07, upon which execution may issue, according to law.

2. Judgment in favor of Plaintiff Cyanotech Corporation and against Biotec Foods-Hawaii, Ltd. in the amount of \$16,899.44, plus interest of \$4,694.79, plus statutory attorney commissions of \$1,164.86, plus costs of \$2,199.94, for a total of \$24,959.03, upon which execution may issue, according to law.

B. On Defendant's Counterclaim

1. Judgment in favor of Plaintiffs Nutrex, Inc. and Cyanotech Corporation and against Defendant Biotec Foods-Hawaii, Ltd., (a) dismissing Defendant's Counterclaim with prejudice, and (b) awarding statutory attorney commissions to each of the Plaintiffs in the sum of \$5,617.26, for a total of \$11,234.52, upon which execution may issue according to law.
